8	located on approximately 26-acres of land at 144
9	Glenn Curtis Boulevard, Uniondale, New York (the

9	property taxes for a period of up to twelve (12)
10	years, consistent with the polices of the Agency.

14	written comments from all persons with views in
15	favor of or opposed to either the proposed
16	financial assistance to the Company or the
17	location or nature of the Facility. At the
18	hearing, all persons will have the opportunity to

22	proposed facility.
