<u>Valley Stream Green Acres LLC</u>—Tenant Consent for Valley Stream Green Acres - American Eagle: Eric Mallette made a motion to adopt a Tenant Consent for Valley Stream Green Acres - American Eagle, 1045 Green Acres Mall, Valley Stream, NY, 11581. American Eagle, will occupy 6,755 square feet of space and will create 9 full time employees. This motion was seconded by Jack Majket. All were in favor. Motion carried.

<u>Valley Stream Green Acres LLC– Tenant Consent for Valley Stream Green Acres - Potato Corner:</u> Flo Girardi made a motion to adopt a Tenant Consent for Valley Stream Green Acres- Potato Corner, 2034 Green Acres Road, Valley Stream, NY. Potato Corner, will occupy 250 square feet of space and will create 4 full time employees. This motion was seconded by Jim Marsh, All were in favor. Motion carried.

Consideration of a Sales Tax Exemption Extension (1 year, time only) for Green Acres Adjacent LLC: Dan Baker representing Macerich requested an extension of the sales tax exemption for 1 year, one time only for Green Acres Adjacent LLC to finalize cleanup of the last pad. Flo Girardi made a motion to adopt the Sales Tax Exemption Extension for Green Acres Adjacent LLC. This motion was seconded by Eric Mallette. Jack Majket voted in favor and James Marsh voted against the tax exemption extension. Motion failed.
