**Public Comment:** The Chairman opened the floor to comments by the public. There was no public comment.

Village of Freeport: No new Business

#### **New Business:**

Consideration of a Due Diligence Inducement for Ocean Avenue Marina Inc.: Flo Girardi made a motion to approve a Due Diligence Inducement for Ocean Avenue Marina, Inc. The project would include construction of a (4) story residential apartment building. The building will consist of one and two bedroom apartments. The location is approximately 3.58 acres and the new building will be approximately 135,406 square feet. This motion was seconded by Eric Mallette. Tom Grech was in favor; James Marsh was not in favor of the Inducement. The motion failed.

#### Village of Hempstead:

Consideration of an Authorizing Resolution for Main Street Hempstead: Dan Oppenheimer made a motion to approve an Authorizing Resolution for 257 Main Street, within the Village of Hempstead. The applicant is proposing to develop and construct the site as a residential rental apartment building with a total of 173 units, and 2,258 square foot of ground retail space. The building will be approximately 147,270 square feet, on approximately 1.684 acres. This motion was seconded by LaMont Johnson. Eric Mallette and James Marsh were not in favor of the project. Motion carried

<u>Consideration of a Termination of Benefits for Alphamore LLC</u>: 50 Clinton Street, Hempstead due to a non-payment of PILOT (tabled from August 26). Flo Girardi made a motion to table Alphamore LLC. This motion was seconded by Tom Grech. All were in favor. Motion carried. This item was tabled.

Consideration of an Authorizing Resolution for an Assignment and Assumption from 303 Main Street

Apartment Investors LLC,: Flo Girardi made a motion to approve an Authorizing Resolution for an Assignment of
303 Main Street, Hempstead, to Castle Lanterra Acquisition LLC/303 Main. The applicant intends to acquire 303 Main
Street, Hempstead and requested an assignment of the existing TOH IDA PILOT on the property. The 211,996 square
foot building is housed on 1.76 acres, and is a 166 unit multi-family apartment complex. This motion was seconded by
Dan Oppenheimer. All were in favor. Motion carried
