1 Newbridge Residence at 558 LLC 3 2 MR. LODATO: Good morning. Му 3 name is Michael Lodato. I'm the 4 Deputy Executive Director of the 5 Town of Hempstead IDA. We're here 6 for a public hearing for the 7 Newbridge Residence at 558 LLC. I 8 will now read the Public Hearing 9 Notice into the record for the 10 stenographer: 11 "Notice is hereby given that a 12 public hearing pursuant to Title 1 of Article 18-A of the New York 13 14 State General Municipal Law (the 15 "Hearing") will be held by the Town 16 of Hempstead Industrial Development 17 Agency (the "Agency") on the 2nd day of December, 2025, at 9:30 a.m., 18 19 local time, at Town of Hempstead 20 Town Hall, Town Hall Courtroom, 350 21 Front Street, Town of Hempstead, New 22 York, in connection with the 23 following matters: 2.4 The Newbridge Residence at 558 25 LLC, a limited liability company

1 Newbridge Residence at 558 LLC 4 2 organized and existing under the 3 laws of the State of New York, on behalf of itself and/or the 4 5 principals of The Newbridge Residence at 558 LLC and/or an 6 7 entity formed or to be formed on 8 behalf of any of the foregoing 9 (collectively, the "Company"), 10 submitted its application for 11 financial assistance (the 12 "Application") to the Town of 13 Hempstead Industrial Development 14 Agency (the "Agency") to enter into 15 a transaction in which the Agency 16 would assist in the acquisition of 17 an interest in an approximately 1.15 18 acre parcel of land located at 558 19 Newbridge Road, East Meadow, Town of 20 Hempstead, Nassau County, New York 21 (the "Land"), the construction of 22 two (2) buildings totaling 23 approximately 21,210 square feet of 24 the Land, including on-site parking 25 and associated site improvements

1 Newbridge Residence at 558 LLC 5 (collectively, the "Improvements"), 2 3 and the acquisition of certain furniture, fixtures, equipment and 4 5 personal property necessary for the completion thereof (the "Equipment"; 6 7 and together with the Land and the 8 Improvements, the "Facility"), which 9 Facility would be subleased by the 10 Agency to the Company and further 11 sub-subleased by the Company to future tenants for use as a 20-unit 12 13 multifamily residential rental 14 facility consisting entirely of 15 two-bedroom units (the "Project"). 16 The Agency contemplates that it 17 would provide financial assistance 18 to the Company in the form of 19 exemptions from mortgage recording 20 taxes in connection with the 21 financing or any subsequent 22 refinancing of the Facility, 23 exemptions from sales and use taxes 2.4 and abatement of real property 25 taxes.

1 Newbridge Residence at 558 LLC 6 2 The Company has requested that 3 the Agency provide financial 4 assistance to the Company in the 5 form of an abatement of the real 6 property taxes for a term of up to 7 twenty (20) years (the "PILOT 8 Benefit"). The proposed PILOT 9 Benefit deviates from the Agency's 10 uniform Tax Exemption Policy and 11 Guidelines, as amended to date (the 12 "Policy"), because the proposed 13 PILOT Benefit would be for a term of 14 up to twenty (20) years instead of 15 ten (10) to fifteen (15) years. 16 Copies of the proposed PILOT payment 17 schedule are available on the 18 Agency's website at www.tohida.org. 19 The Agency is considering the 20 proposed deviation from the Policy 21 due to the current nature of the 22 property and because the Company 23 would not undertake the Project and 2.4 the Project would not be 25 economically viable without a PILOT

Benefit for a term of up to twenty

(20) years.

A representative of the Agency will, at the above-stated time and place, hear and accept oral comments from all persons with views in favor of or opposed to either the Project or the financial assistance requested by the Company. Comments may also be submitted to the Agency in writing or electronically prior to or during the Hearing by e-mailing them to idamail@hempsteadny.gov. Minutes of the Hearing will be transcribed and posted on the Agency's website.

Members of the public have the opportunity to review the application for financial assistance filed by the Company with the Agency and an analysis of the costs and benefits of the proposed Project, which can be found on the Agency's website at www.tohida.org.
